Pedestrian Awareness & Safety	Discussion surrounding the speed of traffic, driver courtesy and pedestrian safety; key points included:
	 Traffic along Birch can move quickly, and pedestrians should be aware of their responsibility in crossing safely. Are there sufficient 30 KM/hr signage throughout municipal roads?
	 Could you have traffic calming measures or speed bumps along Birch Ave? Can the speed board be placed on Birch Ave.?
Public Awareness & Campaigning	Concept of spreading awareness on local radio station and conducting interviews to spread the message about accessibility challenges, public safety and awareness.
Transit Stops	Transit stop at the corner of 2 nd & Birch Ave can be challenging as there is no drop down on that curb and public parking can impeded the transit bus from pulling into the bus stop space.

Accessibility Committees	Can we invite members from other community accessibility committees? The Williams Lake committee members have offered to come and visit 100 Mile House to share success stories. M. Dewing will follow up.
Accessibility Assessor	Invite Wally Bramsleven to come to a meeting to discuss his expertise, accessibility, and commercial construction.
