D	DELEGATIONS
China Economic Tour	Ken Harper (Trinity Post & Panel) and Brad Johnson (Sitka Log Homes) appeared before Council to speak about the value of a recent "economic opportunity tour" to China with local elected officials. Mr. Harper noted that the trip was a "real eye opener to the opportunities and markets presented on the global stage". Mr. Harper noted that the level of investment in local infrastructure in the areas visited were staggering. The opportunities are there; however realizing those opportunities and opening the market is a challenging exercise. Time will reveal the true success of the visit – it's encouraging at this point. Brad Johnson reported that his company was already working in markets across the globe but China was always this "giant across the way" that as of yet was an untapped market. It was a tremendous learning experience; and on their own, could not have achieved near as much during the visit without the local elected officials being on the tour. "If the opportunities identified come to fruition; it will change our community in ways we could never have imagined." Brad further stated that he "can't see how trips like this are not a benefit to us" – "all in all a very positive experience."
