Commissionaires Report – May 2018	H1 BE IT RESOLVED THAT the By-Law Officer report for the period of May 1 to 31, 2018 be received.
Provincial Employee Health Tax	H2 WHEREAS the Province of BC has introduced an Employer Health Tax (EHT) in the form of a new 1.95% payroll tax starting January 1, 2019 in order to replace the Medical Service Plan (MSP) premiums which will not be fully phased out until January 1, 2020; and WHEREAS in 2019 the District of 100 Mile House will be required to pay approximately \$25,000 for the EHT in addition to the \$7,650 for the MSP which will require a 1.0% property tax increase to fund the additional costs; and WHEREAS the EHT will transfer the tax burden from individuals to businesses causing unintended consequences on the local taxpayers as the primary source of revenue for local governments is through property taxation; THEREFORE BE IT RESOLVED THAT the Province of BC exempt local governments, regional districts and school board from the imposition of the EHT to lessen the financial burden on local taxpayer, especially those that are on fixed incomes.
