In December there were 3 Requests for Service:

- Attending commercial property on Birch to confirm how many units are present. Two new businesses are in the building without business licences or proper units. Owner was contacted. - Ongoing
- Left warning on a commercial truck parked on Cariboo Trail. Parking in a two-hour parking zone overnight or on the weekend.
- Complaint received regarding a vehicle that parks all day in a two-hour parking zone. Issued a warning, and then spoke with the owner.

Other issues dealt with in December:

- Spoke with 1 dog owner requesting that the dog be put on a lease. Owner complied.
- Spoke with 2 businesses about the placement/stockpiling of snow on a road right of way. Also left notices at 2 other businesses about snow removal.
- Cube van parked on Alder Ave. for extended period of time. Checked with Super 8 Motel and they do not have any guests that own the vehicle. Issued warning if the vehicle is still there in January it will be towed.
- Hand delivered notice to resident on Scott Rd.
- A businessperson requested information on another business that is not following Covid 19 rules. Gave them the information they needed.
- A transport truck was stuck in the alleyway behind Kondola's due to a car parked contrary to bylaws in the alley. The owner was located and given a verbal warning that parking in that location risks the vehicle being towed.

## **COVID-19 MANDATORY VACCINATION POLICY**

### **1. POLICY**

### **STATEMENT**

The health and safety of District employees is a priority. **The District of 100 Mile House (the “District”)** remains committed to taking reasonable precautions to protect the health and safety of our employees and the public whom we serve from the hazards of COVID-19. This policy has been created to minimize the risks associated to contracting COVID-19 by requiring all District of 100 Mile House employees, volunteers, and contractors to be vaccinated. Adopting this policy is critical as a control method to minimizing risks of COVID-19 and its variants.

## 2. **BACKGROUND AND CURRENT SITUATION**

The COVID-19 pandemic resulted in severe disruption to our workplaces and communities due to its significant health and safety risks. Public health officials, scientists and other medical experts have communicated repeatedly that vaccination is the best defense currently available for preventing workplace transmission. Additionally, vaccination is the best defense for preventing serious illness, hospitalization, and death.

As of October 15, 2021, both Interior Health and Northern Health introduced a “circuit breaker” to try and minimize infections in communities. Given the continuous spread of COVID-19, including the Delta and Omicron variants, the compelling data demonstrating a higher incidence of COVID-19 among the unvaccinated population and the increasing levels of contact between individuals as businesses, services, and activities have reopened to almost full capacity, it is important for District employees to be fully vaccinated in order to protect themselves against serious illness from COVID-19 as well as to provide indirect protection to others, including colleagues.

## 3. **SCOPE OF POLICY**

This policy applies to all employees regardless of workplace or worksite location.

To ensure a safe workplace, contractors, paid-on-call firefighters, and other volunteers entering a District owned and/or operated facility or worksite interacting with District staff will be required to be fully vaccinated. Contractors working with the public on behalf of the District are also required to be vaccinated.



Moving forward, all applicants for employment with the District of 100 Mile House are required to be fully vaccinated against COVID-19 as a condition of being offered employment, subject to the District's accommodation obligations.

#### **4. SUPPORT FOR VACCINATIONS**

The District of 100 Mile House is dedicated to employee safety. In support of employees obtaining their COVID-19 vaccination, District employees can be released on work time to be vaccinated. Talk to your supervisor about an appropriate time during work hours to go if you are unable to attend off hours.

#### **5. COMPLIANCE WITH ALL HEALTH AND SAFETY PRECAUTIONS**

Unless a legislated or regulatory exemption applies, all District of 100 Mile House employees are expected and required to continue to comply with applicable health and safety measures to reduce the hazard of COVID-19, including but not limited to compliance with established workplace access control (e.g. screening), wearing a mask or face covering, using provided PPE, maintaining appropriate physical distancing and self-monitoring of potential COVID-19 symptoms when at work or otherwise engaged in District business.

Employees who remain unvaccinated due to a substantiated Human Rights Code related accommodation may be required to take additional infection and prevention control measures.



## 6. ROLES AND RESPONSIBILITIES

Management and employees are responsible for safety in the workplace

### Managers and Supervisors

- All managers and supervisors are to comply with the policy by being vaccinated
- Continue setting and leading by example by complying with and maximizing all safety practices, especially those related to COVID-19
- Addressing any safety concerns or breaches relating to Health and Safety in the workplace

### Employees

- All employees are to comply with the policy by being vaccinated
- Follow all COVID-19 safety protocols
- Report any safety concerns or breaches relating to Health and Safety in the workplace to their Supervisors/Managers

### New Employees

- All new employees with the District of 100 Mile House are required to be fully vaccinated prior to obtaining employment subject to the District's accommodation obligations.

### Paid-On-Call Firefighters, other Volunteers and Contractors

- Are required to comply with the Vaccination Requirements set above



## 7. PROOF OF VACCINATION

District of 100 Mile House employees must provide Proof of Vaccination by March 15, 2022. For this policy the following will constitute as satisfactory proof:

- BC Vaccination Card or BC Electronic vaccination card
- BC's digital vaccination QR code, displaying the employees legal name along with a matching ID (i.e. Driver's license)
- A document issued by any provincial government for the purpose of showing proof of vaccination for public health or travel purposes
- Federal Vaccination Card

The District will not maintain copies of any of the above documents but will record confirmation of status of employees only. This information will only be used to the extent necessary for implementation of this policy, for administering health and safety protocols, and infection control measures in the workplace.

## 8. CONSEQUENCES OF NON-COMPLIANCE

Failure to provide proof of vaccination by March 15, 2022, will result in employees disqualifying themselves from attending work. After four weeks leave without pay, employment of employees who refuse to be vaccinated and do not have an approved accommodation under the provisions of the *Human Rights Code* of BC will be terminated. Please obtain information from EI regarding benefits, as employees who are absent from work and unpaid due to remaining unvaccinated may not qualify for EI benefits.





**9. ONGOING MONITORING AND ASSESSMENT OF COVID-19 WORKPLACE SAFETY MEASURES**

The District will continue to closely monitor its COVID-19 risk mitigation strategy and the evolving public health information and context, to ensure that it continues to optimally protect the health and safety of employees in the workplace and the public that they serve. To that end, and in consultation with Interior Health, WorkSafe BC and Occupational Health and Safety Experts, the District will continue to assess other available workplace mitigation measures.

## Appendix "A" – Definitions

COVID-19: SARS-CoV-2 CORONAVIRUS, INCLUDING ALL VARIANTS.

COVID-19 Vaccine: A COVID-19 vaccination series authorized by Health Canada

Employee(s): all District employees regardless of workplace or worksite location, including those employees working remotely or teleworking.

Fully Vaccinated: having obtained all required doses of a COVID-19 Vaccine

Proof of vaccination: BC Vaccination Card or BC Electronic vaccination card, BC's digital vaccination QR code, displaying the employees legal name along with a matching ID (i.e. Driver's license), document issued by any provincial government for the purpose of showing proof of vaccination for public health or travel purposes

Human Rights Code of BC: The Code helps to protect you from discrimination and harassment. The independent Human Rights Tribunal is responsible for dealing with complaints under the Human Rights Code.
