## **ELECTOR REGISTRATION & QUALIFICATIONS**

The District uses the provincial voters list as its list of resident electors. If you are not on the list of electors, you may register at the time of voting by completing the application form available at the voting place and making a declaration that you meet the requirements to be registered as set out below:

#### RESIDENT ELECTORS

To register as a resident elector you must:

- be 18 years of age or older on general voting day [October 15, 2022];
- be a Canadian citizen;
- $\bullet$  be a resident of British Columbia for at least the past 6 months;
- be a resident of the District of 100 Mile House; and
- not be disqualified by law from voting in an election.

#### NON-RESIDENT PROPERTY ELECTORS

To register as a non-resident property elector you must:

- be 18 years of age or older on general voting day [October 15, 2022];
- be a Canadian citizen;
- be a resident of British Columbia for at least the past 6 months;

- be a registered owner of real property in the District of 100 Mile House for the past 30 days;
  not be entitled to register as a resident elector; and
- not be disqualified by law from voting in an election.
- That be disqualified by law from voiling in an election

**To register, resident electors** must produce **2 pieces of identification** (at least <u>one</u> with a signature). Picture identification is not necessary. The identification must prove both residency and identity.

To register, non-resident property electors must produce 2 pieces of identification (at least one with a signature) to prove identity, proof that they are entitled to register in relation to the property, and, if there is more than one owner of the property, written consent from the other property owners.

District of 100 Mile House electors may choose to vote by mail. Mail ballot packages can be requested at the municipal office during regular business hours (up until October 13th, 4:00pm)
